

# Stallion Incentive Program



The **ABHA Stallion Incentive Program** is awarded from progeny sired by stallions nominated in the ABHA Stallion Incentive Program. All proceeds collected from the ABHA Stallion Incentive Program and Auction will go towards a bonus at the 2024 ABHA National Finals for eligible horses entered in the Futurity, Maturity and Open Divisional. The highest placed horse in each event listed will determine the winners of the bonus.

Payouts will be split equally between the 3 events as follows: 45% stallion owner, 45% rider and 10% ABHA.

**Continuing in 2024, The ABHA Stallion Incentive Program requires an entry fee of \$55 to eligible progeny increasing the funds able to paid out in 2024!**

Two options for payment on/or behalf of stallion owner:

## OPTION 1



### NOMINATE STALLION BY DONATING BREEDING TO STALLION AUCTION.

Minimum bids start at \$350 (covers nomination fee). If minimum bid is not met the service will not be awarded and the stallion owner is responsible for paying the \$350+GST nomination fee for the stallion to remain in the Stallion Incentive Program.



## OPTION 2

### NOMINATE STALLION BY PAYING FEE ONLY

\$350+GST Nomination fee due in to the ABHA by July 31st 2024. Any enrolments after this day will have a \$150 late fee.

**Please Note:** If you choose option one, please complete the confirmation form attached. The stallion auction will open 1 August 2024 at 7pm and will close 15 August 2024 at 7pm EDST via Facebook. You will get a lot of publicity from the Stallion Auction!

2. No refunds for any reason. Death of stallion, inability to collect, sold stallions must be handled between stallion owner and winning bidder. The ABHA Stallion Incentive Program will be held harmless in these matters.

3. It is further understood that the auction is to be held on Facebook and will open 1 August 2024 at 7pm and will close 15 August 2024 at 7pm EDST. The donor reserves the right to bid on his/her own behalf.

4. The bidding will begin at not less than \$350. If minimum bid is not met stallion owner is responsible for paying the \$350+GST nomination fee for the stallion to remain in the Stallion Incentive Program.

5. Bids will be accepted in \$50 increments and only accepted through the Australian Barrel Horse Association Facebook page on the individual pictures of each stallion.

6. A live foal guarantee is required with this contract.

7. You will be provided with the name, address and phone number of the winning bidder.

All Stallion Owners must provide a current copy of the Stallion's Contract for the ABHA to provide to any potential bidders. The ABHA will oversee the signing of the contract & return to Stallion Owner with winning bidders details.

# Stallion Incentive Program Rules

1. The ABHA govern the Futurity, Maturity, Open and Stallion incentive program and reserves the right to refuse entry to any horse or individual. All decisions are final.
2. All horses must be registered to be eligible for The ABHA Stallion Incentive Program. (Quarter Horses, Stock Horses, Thoroughbreds and Paint Horses).
3. All horses must be by a current stallion paid into The ABHA Stallion Incentive Program.
4. Progeny can be by stallions who are deceased or gelded, however the stallion must be paid in for progeny to be eligible.
5. A person or persons could pay in a stallion, if the stallions registered owner chooses not to. The ABHA must receive written permission from the registered owner of the stallion.
6. Owners do not have to ride horses and riders may ride more than one horse.
7. A copy of all registration papers must be submitted when entering.
8. At no point during the event can a member come to the ABHA to submit registration paperwork; your horse will not be eligible if not approved upon entering.
9. The ABHA Stallion Incentive Program provides a bonus exclusively for eligible progeny sired by enrolled stallions in The ABHA Stallion Incentive Program.
10. The percentages of money will be split evenly between the 3 events: 45% stallion owner, 45% rider and 10% ABHA.
11. Futurity and Maturity horses are eligible to run for the bonus if entered in the open divisional.
12. Number of places paid will be pending the amount of money raised by the stallion auction and number of enrolled stallions.
13. All eligible progeny are to pay \$55 upon entry to be compete in The ABHA Stallion Incentive Program. If you do not pay this fee upon entry, there will be a \$25 late fee to enter.
