# Item <u>Presidents Report:</u> 5

The 2022-23 ABHA season has been a very successful year for the association.

We have experienced a growth in new affiliates with an increase of 14 and a large number of affiliates returning to the ABHA in particular in QLD.

We have 835 Senior, 677 Junior and 21 non competing.

We had 118 events Australia wide and have 86 current affiliates.

The 2022 Equitana event was a huge success and production and due to the crowd response, I am excited to announce that barrel racing will feature for two days at the 2025 events.

The 2023 National Finals has seen record entries in the junior section with 229 and also record entries in the futurity. The ABHA has also received a record cash sponsorship for this year's and also a record for traders at the events.

The board is also excited to advise that we have invested into a new online entry system designed for barrel racing and is an asset that ABHA will own. Members and affiliates will greatly benefit form owing our own system due to ease of use, Reduced paperwork and reduced fees into the future with no ongoing transaction fees and annual usage fees.

Also, part of this system will be a brand-new state of the art website with ease of functionality and new features to improve the ABHA experience for members and affiliates.

I would like to take the opportunity to thanks the board for a great year and looking forward to the 2023-24 season.

## Discussions:

Shona Tribe questioned the reasoning for the membership price increase and Cathrina Hutton elaborated on Matt advising the members of the membership increase for 2024 explaining some of the reasonings behind the increase: basically to cover the increased costs of the ABHA registering with the ATO to become an employer of the Secretary & Treasurer, which will now pay tax and superannuation to its employees instead of employing them as contractors.

Senior Membership increase from \$76 to \$100 (GST INC)

Junior Membership increase from \$46 to \$70 (GST INC)

Cathrina Hutton also advised the ABHA is now eligible to apply for technology and research grants.

Susan Keenan questioned the necessity of a new website when the existing website already had its own NF online entry and merchandise facility.

The Board explained the new features the website will feature enabling affiliates to have a "One Stop Shop" to enter and run their events through.

ASHS currently has less members than ABHA but has 200,000 registered horses on their books.
