Stallion Breeders Incentive: Helen McVicar suggested the following:

I Helen McVicar (membership 36) would like to put forward for discussion to the Board & members of the ABHA that at the National Finals there be a Breeders Incentive. Example: The contestant on entering the Finals completes a form where the Sire name for the horse you are competing on & registration number (must be alive) & owners name is completed and a copy of your competition horse's papers for proof of Sire is sent in. Maybe doing a numbering system taking top 20 in each event or even all the horses, the Sire with the most points would be the highest money earner for the ABHA Finals, there for the Owner of the Sire would receive a Trophy & have a Perpetual Trophy for the Club.

Hoping this will encourage our Breeders to become more involved in the sport, also looking after the Breeders that are doing a great job for our sport. Our sport of Barrel Racing has grown so much over the past years with our home grown Stallions & the Imported Stallions. This will benefit the breeders by increasing the value of their foals & will help our sport of Barrel Racing into the future
